1. The Scout should pay as much as possible.
2. The unit or chartered organization should pay as much as possible.
3. The unit should provide money-earning opportunities for Scouts.
4. Unit Committees should apply only for the balance needed after the above sources are exhausted.
5. Scouts should be assigned some task to perform commensurate with the campership, so they have the feeling of earning their own way.
6. The maximum for a campership is 1/2 of the camp fee.

**Deadline for application is May 1, 2010**

Scoutmasters/Cubmasters will be notified, if a campership has been approved and if so, the amount.
